Deliberations	The Registrar, Dr. U. Eranna, who also serves as the Member Secretary of the Academic Council, welcomed all members to the virtual meeting and informed them that the purpose of this Special Academic Council Meeting was to seek approval for conferring the degree of Doctor of Philosophy (Honoris Causa) upon Sri Siddalinga Maha Swamigalu, Suvarnagiri Virakta Math, Vala, Ballari, during the First Convocation of Kishkinda University on 24th December 2025. The Hon'ble Vice-Chancellor, Prof. T.N. Nagabhushana, who also serves as the Chairperson of the Academic Council then addressed the Council, highlighting the University's progress since its establishment in 2023, including the shift to a new permanent campus of 49.51-acres with modern facilities and an enrolment of about 2,500 students.
